41/20 MINUTES

Upon being moved by Councillor Dr Withams and seconded by Councillor Potts, the Minutes of the meeting of the Committee held on 14th December 2020 were approved as a correct record.

42/20 MEMBERS' INTERESTS

No interests were declared in respect of items appearing on the agenda.

43/20 MATTERS ARISING

The Committee considered the following matters arising from the Minutes of its meeting held on 14th December 2020:-

(a) District Council Development Management Committee

Further to Minute No. 36/20, the Chairman reported that he had attended a meeting of the District Council's Development Management Committee held on 14th December 2020 at which application 19/02517/FUL for 20 car parking spaces to be provided south of the Parish Church had been considered. The Parish Council had recommended approval of the application but it had been recommended for refusal by Planning Officers. The Chairman reported that the Committee was in favour of approval but had deferred a decision, pending the submission of a biodiversity report and information on replacement trees.

(b) Fenside Caravan Park, Puddock Hill

Further to Minute No. 39/20, the Clerk informed Members that Solicitors acting on behalf of the owner of Fenside Caravan Park had submitted an appeal to the Court of Appeal against the decision in the High Court over the interpretation of a certificate of lawful development issued by the District Council in respect of the site. The site appeared to have been occupied in breach of the current planning permission for some time and it recently had become apparent that caravans on the site were being advertised as accommodation on Facebook. Under the circumstances, the Clerk reported that he was continuing to seek an assurance from the District Council's Planning Service that the delays caused by the legal process would not prejudice subsequent enforcement action given the length of time that the planning conditions had not been observed
